Announcing a competitive entrance examination and fixing the number of places for admission into Level II of the "Ingénieurs" Programme specializing in Agronomy and Forestry (Campus of Dschang), and into Level II of the Professional School of Wood, Water (Ebolowa Antenna) of the Faculty of Agronomy and Agricultural Sciences (FAAS), at the University of Dschang, for the 2017/2018 academic year.

ORDERS:

Competitive Examinations into Cameroon State Universities for the 2017-2018 academic year;

Article 1: A special competitive entrance examination is open for admission of twenty (20) students into Level II of the "Ingénieurs" Programme specializing in Agronomy and Forestry (Dschang Campus), and twenty (20) students into level II of the Professional School of Wood, Water (Ebolowa Antenna) of the Faculty of Agronomy and Agricultural Sciences (FAAS), for 2017/2018 academic year.

This examination shall take place on the 17th and 18th August at the following centres: Douala, Dschang, Ebolowa, Ngaoundere and Yaounde.

- <u>Article 2</u>: (1) For the Programme specializing in Agronomy and Forestry (Dschang Campus) the entrance examination is open to Cameroonians of both sexes holding a Certificate of Senior Agricultural Technicians or Senior Forestry or Agroforestry Technicians with the "Baccalauréat" (scientific series) or the General Certificate of Education Advanced level (GCE«A» Level) in at least two science subjects or the holders of a Scientific DEUG (two years in a Faculty of Sciences) or any other equivalent certificate recognized by the Ministry of Higher Education.
- (2) For the Professional School of Wood, Water (Ebolowa Antenna) of the Faculty of Agronomy and Agricultural Sciences the entrance examination is open to Cameroonians of both sexes who are holders of the Certificate of Senior Technicians in Water sciences and engineering, in Wood technology or Senior Forestry or Agroforestry Technicians or Senior Technicians in Environmental Sciences with the



"Baccalauréat" (scientific series) or the General Certificate of Education Advanced level (GCE«A» Level) in at least two science subjects or the holders of a Scientific DEUG (two years in a Faculty of Sciences) in Biology, chemistry, physics, environmental sciences or any other equivalent certificate recognized by the Ministry of Higher Education.

- (3) Citizens of member countries of the Central African Economic and Monetary Union (CEMAC) who have ratified texts on national treatment of students and who are holders of equivalent qualifications are eligible to write the entrance examination under the same conditions as their Cameroonian counterparts.
- (4) Candidates from other countries including CEMAC member countries who do not write the entrance examination but hold a scholarship from their Government or International Organization may apply for direct admission, which is contingent upon the number of available places and payment of 1.000.000 (One million) FCFA/year as tuition fees.
 - (5) The twenty (20) students of the Dschang Campus shall be distributed as follows:
 - (15) For those who write the entrance examination, and among them:
 - 10 for holders of the Junior Technicians Certificate;
 - 05 for holders of the DEUG
 - (05) For those applying for direct admission (file study)
 - (6) The 20 students of the Ebolowa Campus shall be distributed as follows:
 - 15 for those who write the entrance examination, and among them:
 - 10 for holders of the Junior Technicians Certificate;
 - 05 for holders of the DEUG
 - 05 for direct admission (file study).

<u>Article 3</u>: Each candidate should forward to the Students Records Service of FAAS, not later than 14 August 2016, complete applications file comprising the following documents:

- 1. An application form downloaded following the procedure of online registration from the University Website SIGES ONLINE at the address http://sigesonline.univ-dschang.org;
- 2. A Certified-true photocopy of the GCE "A" Level certificate or "Baccalauréat" (scientific series and agriculture) or an equivalent certificate, or a certified copy of results slip;
- 3. A certified-true photocopy of "Baccalauréat" and "Probatoire" transcripts or certified-true photocopy of GCE results;
- 4. A certified-true photocopy of birth certificate (issued not more than 3 months old);
- 5. A medical certificate of fitness for manual work and sports signed by a government Medical Practitioner;
- 6. 4 passport size photos (4x4), (write the name at the back of each photo);
- A receipt of payment of 20.000 (Twenty thousands) FCFA as application fees issued by BICEC-DSCHANG at the account N°96196538001-56 or by any financial establishment chosen during the online registration process;
- 8. A large (A4 SIZE) self-addressed stamped envelope (postage determined with the contents of file).
- 9. The candidate should deposit the physical file in the Faculty of Agronomy and Agricultural Sciences or in the different Antennae of the University of Dschang in Yaounde, Maroua, Ebolowa, Bambui, Belabo and Bafia, or in Regional or Divisional Delegations of Secondary Education (in towns where University Antennae are not present).

Article 4: The application fees are non-refundable.

Article 5: Only candidates who submit complete application files shall be authorized to write the entrance examination.

Article 6:

- 1°) The entrance examination shall comprise a written part and an assessment of the candidates Previous academic records (file study).
- 2°) The written examination shall comprise the following papers:

3°) The programme of study is the one being followed in the classes preparing students for certificates required to write the entrance examination.

Article 7:

- 1°) Each paper shall be marked out of 20 points and a score and a score below 04/20 in any of the papers shall eliminate the candidate.
 - 2°) Assessment of candidates previous academics records shall be based on :
 - · Transcripts of Level I and Level II for holders of DEUG;
 - Transcripts of Year I and Year II for holders of the Senior Technicians Certificate;
 - The number of times the candidate repeated.

Article 8:

- 1°) The final mark in the examination shall be calculated as follows: 60% for the written examination and 40% for the candidates' previous academic record.
- 2°) The results will be compiled and prepared by a panel appointed by the Minister of Higher Education on the proposal of the Rector of the University of Dschang.

Article 9: The Rector of the University of Dschang, the Director of University Accreditation and Quality and the Dean of FASA are, each in his capacity, responsible for implementation of this order which shall be registered and published in English and French wherever necessary.
