1. SUBJECT

The Vice-Chancellor of the University of Dschang (Contracting Authority) here-by launches on behalf of this Institution, a consultation by call for quotation for ensuring the external and internal upkeep of campuses A, B and C of the University of Dschang.

2. PARTICIPATION

Participation in this consultation is open under the same conditions to physical and moral individuals having the capacity to render the services in question.

3. FUNDING

The services in question are funded by the Autonomous Budget of the University of Dschang, Management budget, 2018 fiscal year and beyond.

4. NATURE OF WORK TO BE DONE

Services Comprise:

1st allotment: External upkeep:

- General clearing of grass around,
- Pruning of trees, hedges and flours,
- Trimming of lawn
- Picking and doing away with garbage
- Unblocking gutters.

2nd allotment: Internal upkeep:

- Cleaning of lecture halls and amphitheatres,
- Cleaning and disinfecting toilets,
- Cleaning of offices,
- Cleaning of corridors and lanes.

7. DEPOSIT OF BIDS

Bids drafted in French or English, in five (05) copies of which the original and four (04) copies labeled as such, in conformity with prescriptions of the call for Quotation file, shall be submitted with an acknowledgement receipt insued or forwarded by registered mail with an acknowledgement receipt issued by the Unit in charge of Contracts Award of the University of the Dschang, latest February 02, 2018 at 10 am precisely. 8 - ACCEPTABILITY OF BIDS

Tenders shall be accompanied by a submission security of: 1st allotment: 200 000 CFAF; 2nd allotment: 260 000 CFAF issued by a financial Institution authorized by the Minister of Finance.

The validity of the caution shall be one hundred and twenty (120) days, from the dead line of submission of tenders. To avoid rejection, the required administrative documents should be imperatively produced in original copies or copies certified by the issuing service, in conformity with items contained in the particular regulation of the Call for quotation, and should absolutely be less than three (03) months old.

Any bid that is not in line with the prescriptions of this call and the call for Tenders file, shall be disqualified, especially the absence of a submission security issued by a financial institution approved by the Minister of Finance, the non respect of samples of documents of the call for Tenders file, a false declaration, a falsified document, will make the bid to be rejected without any possibility of appeal.

NB: cheques, even when certified are not accepted in the place of the submission security

9. OPENING OF FILES

The opening of files shall be done on February 02, 2018 at 11 a.m. precisely, in the Conference Hall of the Rectorate of the University of Dschang. This will be done by the

Internal Commission for contracts Award of the University of Dschang, in the presence of bidders who so wish or their representatives duly mandated and having perfect mastery of the tender concerned.

10. DEAD LINE OF EXECUTION

It shall not go beyond twelve (12) months.

11- NUMBER OF LOTS

This call for tenders is made up of two lots.

12- MAIN EVALUATION CRITERIA

12.1. Eliminatory criteria:

- 1. incomplete of administrative file
- 2. False declaration or falsified document
- 3. File having obtained less than eighty percent (80%) "Yes" in the essential evaluation criteria.
- 4. Absence of declaration on the honor of not abandoning a public contract during the last three years.

12.2. Essential Criteria

The technical know-how of each bidder shall be evaluated according to the following binary marking:

- 1. Presentation of offer
- 2. Capacity of pre-funding, access to a credit line or the financial resources
- 3. Similar work already done
- 4. material and execution matter
- 5. Staff
- 6. Execution programme

13. AWARD OF CONTRACTS

The contract shall be awarded to the bidder whose technical offer is the least demanding.

14. VISIT OF SITE

The site visit to be done after purchase of the Call for Quotation file, shall be accompanied by a report and if possible pictures taken during the visit.
