1. Subject of Call for Tenders

9. Acceptability of files

To avoid rejection, each bidder should include in his administrative documents, a submission security established by a first class financial institution authorized by the Minister of Finance, the list of which should feature in document N°11 of the Tenders file, valid for thirty (30) days beyond the original date of validity of Tenders. The inherent security is 7 500 000 CFAF.

Other administrative documents required must imperatively be produced in originals or copies certified by the issuing service or an administrative authority (Senior Divisioner Officer, Sub-Divisioner Officer...) in conformity with the clauses of the particular Tender. They must absolutely be less than three (03) months old or should have been established after the date of signature of the Call for Tenders.

No Tender will be accepted if it does not conform to the prescriptions of this Call for Tenders File, such as the absence of a submission security issued by a financial institution authorized by the Minister of Finance or the non-respect of models of documents of the Call for Tenders Files.

10. Opening of Files

The opening of files shall take place in two phases.

The opening of administrative and technical documents shall take place on a date to be determined by the Internal Commission of Contracts Award situated in the first floor, Room 114 of the Chancellery Building of the University, Tel 699 363233, P.O.Box 96 Dschang.

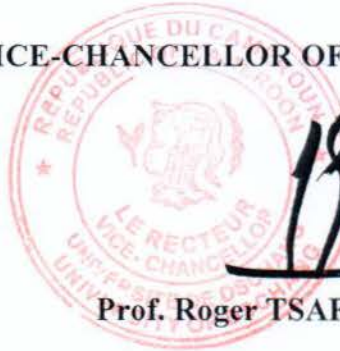
